F.O.I.A. Freedom of Information Act Request for Information

Adopted November 2001 - Revised December 2022

PURPOSE: The Crystal Lake Park District was approved by voter referendum on November 21, 1921. As a Park District, the Crystal Lake Park District's purpose is to acquire and maintain land and facilities for park and recreation purposes, and to organize and supervise planned recreation programs. The Park District's mission is to work with the community to preserve and enhance recreational and open space resources.

Created as a separate unit of government, the Crystal Lake Park District is a municipal corporation and local taxing authority for its stated purpose. It is authorized by legislation to levy and collect taxes, and to establish local policy, ordinances, and resolutions to enact and complete its purpose. It serves approximately 55,000 people in the City of Crystal Lake, Village of Lakewood, and unincorporated McHenry County. The Crystal Lake Park District's annual budget for the fiscal year beginning May 1, 2022, and ending April 30, 2023 is \$21,660,183. The Park District employs approximately 58 full-time employees and 361 part-time employees.

The Crystal Lake Park District Board of Commissioners governs the agency's affairs. There are seven members on the Board, and they are elected for four-year terms of office, without compensation, pursuant to the provisions of the Park District Code found in 70 ILCS 1205/2-12; 70 ILCS 1205/12a. The Board of Commissioners approves policies and plans for the operation of the Park District.

The Crystal Lake Park District Board of Commissioners meet regularly on the 3rd Thursday of each month at 6:30 PM, at the Administrative Offices located at One East Crystal Lake Avenue, Crystal Lake, Illinois 60014. A copy of the 2021 Board Meeting schedule is included.

FREEDOM OF INFORMATION REQUESTS: Freedom of Information requests are accepted by personal delivery, mail, email or oral request to the Crystal Lake Park District Administrative Office, One East Crystal Lake Avenue, Crystal Lake, Illinois 60014, attention: Freedom of Information Officer. A copy of the Freedom of Information Act Request Form is included in this packet.

The Freedom of Information Officer will make a response to the requesting party within five working days of receipt, unless an extended time period is required. Requests will be responded to, in writing, by the Freedom of Information Officer and available for pick up at the Administrative Office.

There is a \$.15 charge for each copy made over 50 pages. Cost for certifying a record will be \$1.00.

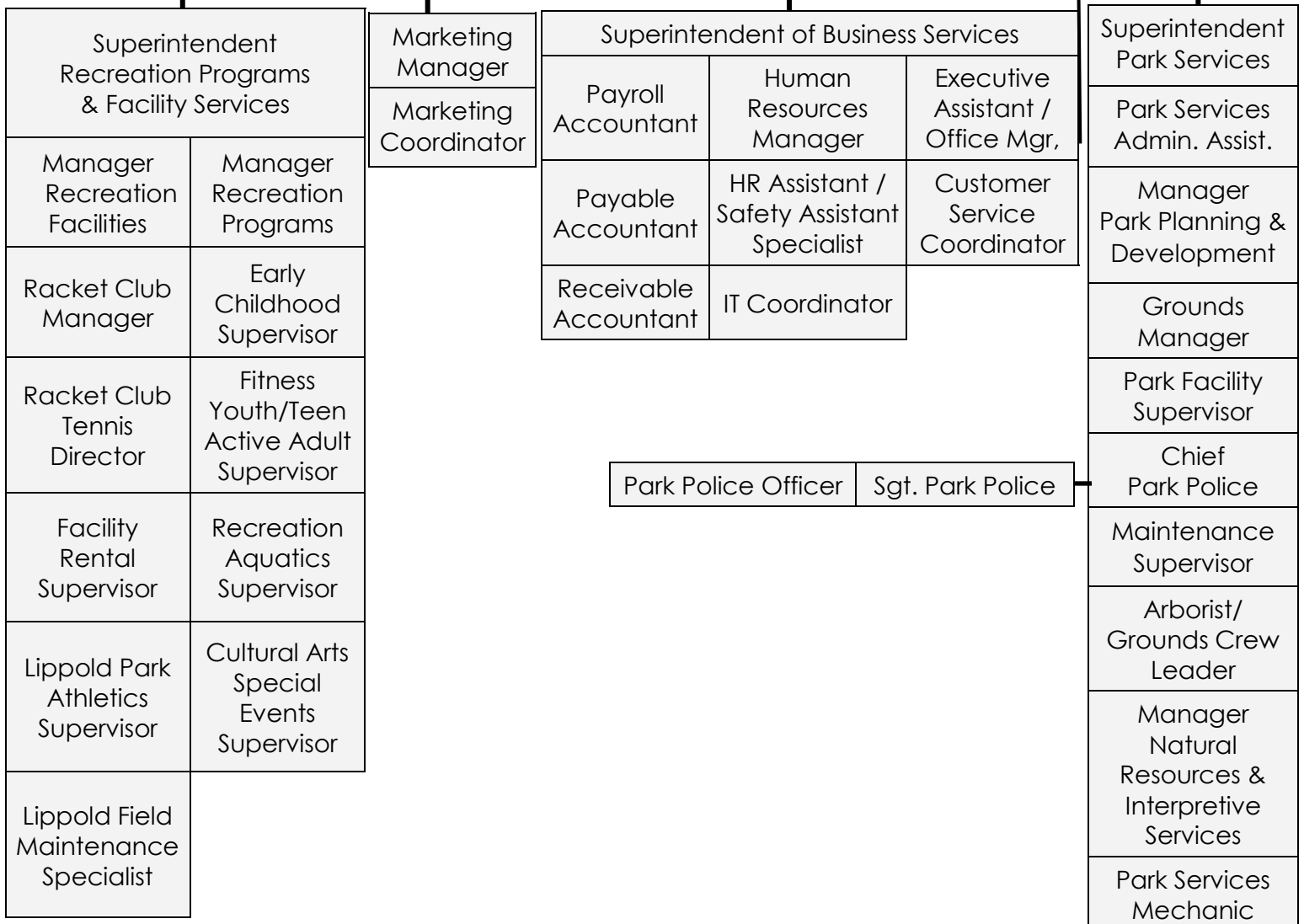
